Purchase of 1 - 2004 Altec A55E-OC articulating over-center aerial device. 1- Altec A50E-OC articulating over-center aerial device, 2 - 2004 Fiberglass Utility Bodies and installation.

ITEM DESCRIPTION:

Plans for vehicle replacement in 2004 include 2 new trucks with aerial device and body for the Electric Maintenance & Construction crews. The 2004 capital improvement budget includes funding for these units. These units replace existing units. Bids were received from three vendors to supply the aerial devices, bodies and installation on an RPU provided cab & chassis's. Chassis purchase was approved at the last Board meeting. Total cost of the units will be below budgeted amounts. Based on our evaluation of the bids which included price, delivery, previous experience with manufacturer and bidder, availability of service and repair facilities, compliance with specifications and operating & maintenance costs, Altec Industries Inc. was determined to be the lowest responsive bid with a price of \$188,650 which includes options for tire chains, two-year warranty, and trading in Trucks V111 and V64.

UTILITY BOARD ACTION REQUESTED:

The Board is requested to approve a purchase order agreement with Altec Industries, Inc., 5201 West 84th Street, Indianapolis Indiana 46268 in the amount of \$188,650 plus sales tax to provide two aerial devices, bodies and installation.
