2006 Electric Revenue Adjustment

ITEM DESCRIPTION:

At the February Utility Board meeting, staff was directed to notice the public of a increase in electric rates due to the impact of a 16.9% increase in our cost of purchase power from RPU's wholesale supplier the Southern Minnesota Municipal Power Agency (SMMPA), which represents 60 % of our operating costs. The Board's preliminary consensus was that a 8.5 % increase was needed to offset the major cost increase of purchase power while maintaining an appropriate cash reserve levels.

Staff recommends that the Board proceed with a recommendation to the City Council for increasing electric rates by 8.5% effective April 4th, 2006 on all the current rate schedules. An 8.5% increase would increase the typical residential bill by approximately \$ 5 per month.

Staff would also recommend that the customer charge for a residential customer be adjusted from \$ 9 to \$ 10, and the general service customer charge be adjusted from \$17 to \$ 20 while maintaining an overall increase of 8.5% in these rate classes. The adjustment to this rate component moves us closer to what our cost-of-service model indicates we should be.
