Consideration of Quotation – Willow Main Level Reservoir Repair Project

ITEM DESCRIPTION:

The Willow Reservoir is located behind the old Mills Fleet Farm store site, and serves the southern portion of the main level service area.

The 1,000,000 reservoir is a fused-glass coated steel panel tank (which does not require periodic painting like our welded steel reservoirs) with a concrete foundation and floor, and an aluminum geodesic dome cover. The reservoir was constructed by Engineering America in 1987. Leakage through the reservoir concrete foundation has been observed in recent years.

Engineering America is the major representative and constructor for this type of tank in the midwest. In 2009, Engineering America was called in to evaluate the leakage and recommend repairs. Temporary repairs were made in 2010 by injecting a sealant into the foundation at the leakage locations. This somewhat reduced, but did not eliminate the leakage.

Engineering America has recommended the installation of an elastomeric liner over the existing tank interior floor, as well as other maintenance items which are due, and can be done while the reservoir is out of service. The repair work to be accomplished by Engineering America is listed on the attached quotation.

The quoted price to accomplish the Willow Reservoir repairs is \$99,500.

Because the project cost is between \$50,000 and \$100,000, Utility Board (but not City Council) approval is required.

FOR CAPITAL PURCHASES/BIDS/MAJOR PROJECTS:

Funds are available in the 2011 Water Utility water storage tank budget for this project.

UTILITY BOARD ACTION REQUESTED:


