### **ITEM DESCRIPTION:**

TSE Model UP-70BD Trailer Mounted Underground Puller/Air Compressor

## FOR CAPITAL PURCHASES/BIDS/MAJOR PROJECTS:

The annual plan for equipment replacement includes one new underground cable puller for Electric Maintenance & Construction. The capital improvement budget included funds for this unit which replaces an existing unit. Quotes were received from four vendors and staff reviewed the capability of the units to determine suitability for the job requirements. A TSE UP-70BD puller quoted by DUECO was selected by the staff based on the price and key capabilities.

The existing unit is beyond its planned life, has been unreliable in recent years, and had increasing repair costs including over \$5,000 in 2008. There is no back up for this critical unit so breakdowns delay work and waste labor resources.

#### **UTILITY BOARD ACTION REQUESTED:**

Management recommends that the Utility Board approve a purchase order agreement with DUECO in the amount of \$84,306.00 plus sales tax.


