SUBJECT: Consideration of Bids – Construction of Municipal Well #40

ITEM DESCRIPTION:

Bids for construction of Municipal Well #40 (Southwest) were opened on September 22, 2009. Five bids were received (see the attached bid tabulation), and E.H. Renner & Sons, Inc. of Elk River, MN, was the low bidder with a bid of \$248,320 for construction of the well. The engineer's estimate for construction of the well was \$293,200

Construction of the well is necessary to provide for water demand in the southern part of the City, which includes the Maine Street/Mills Fleet Farm area, the Airport High Level Service area, the Scenic Oaks area (west of the Willow Creek Golf Course) and to meet additional water demand resulting from future development in these areas.

FOR CAPITAL PURCHASES/BIDS/MAJOR PROJECTS:

\$570,000 was budgeted for construction of the well and wellhouse in 2009. Construction of the well will extend into next year, and the wellhouse will also be constructed in 2010. The proposed 2010 Water Utility budget reflects the change in the project schedule.

UTILITY BOARD ACTION REQUESTED:

Staff recommends the Utility Board accept the low bid, approve a contract agreement for construction of Municipal Well #40 with E.H. Renner & Son, Inc. in the amount of \$248,320 and authorize the Mayor and City Clerk to execute the agreement.
