SMMPA will have a rate increase of 6% in 2016. The main drivers for the increase: no rate increase in 6 years, low MISO prices and additional debt service for Badger Coulee and Owatonna energy station projects.

Dave Reichert asked about the 3 year rate track. Peter reminded the Board of the approved 3 year rate track and the 1.7% rate increase used in the modeling for the budget. Hogan also stated; we felt comfortable sticking to the approved rate track in 2016 but 2017 might be fragile. The board can come back and change the rate increase in future years.

Mark Browning commented that the 6% proposed water rate increase for the next 3 years is what we have reviewed in the past few months as a result of the cost of service study. Browning also asked about the cash reserves policy, Peter Hogan said the updated policy based on the Utility method will come to the board for approval in January.

Steps are being taken to add the number of gallons used to the bill. The average use is 7 units per month.
