SUBJECT: Purchase of One 2011 Altec DM47-TR Digger Derrick,
Utility Body, and Installation

ITEM DESCRIPTION:

Plans for vehicle replacement in 2011 include a new digger derrick truck for Electric Maintenance & Construction crews. The 2011 capital improvement budget included funds for this unit which replaces an existing unit.


Bids were received from two vendors to supply the digger derrick, body and installation on an RPU provided cab & chassis that was approved at the February 22nd, 2011 board meeting. Based on our evaluation of the bids which included price, delivery, previous experience with manufacturer and bidder, availability of service and repair facilities, compliance with specifications and operating & maintenance costs, Altec Industries was determined to be the lowest responsive bid with a price of \$121,776.00 which includes the trade in of Unit V62.

FOR CAPITAL PURCHASES/BIDS/MAJOR PROJECTS:

The total price of the unit is within budget estimates.
