Unit 3-4 High Pressure Feedwater Heater Re-tubing

ITEM DESCRIPTION:

The Unit 3-4 high pressure feedwater heater is scheduled for re-tubing during the upcoming Unit 3 maintenance outage. Funding for the project is provided for in the adopted 2009 Power Resources allocation budget.

Bid documents were prepared and a request for bids was published, and distribute to known contractors. The bid opening took place for January 20, 2009. One "bid" was received, but was rejected by the RPU Board because the submittal: 1) did not provide a firm price or schedule as required by the bid specifications, 2) failed to provide assurance that the contractor possessed sufficient experience working with the model of heat exchanger involved to execute the work properly, and 3) the cost estimate provided in the proposal significantly exceeded the budget for the project.

Bid documents were again prepared and a second request for bids was published and distributed to four known contractors. The bid opening took place on February 17, 2009. Two bids were received with results summarized below.
