4.d. Mr. Rovang, Senior Civil Engineer, discussed the 9th Street NW watermain replacement project with the Board. He said that quotations for the project would not be received until September 28 and that the project could not wait until the October Board meeting for approval due to weather conditions. He said staff is using the standard contract and that the Public Works Department prepared the specifications. Mr. Adkins said that the Board could approve the project, but that if there was a problem with the bids, staff could not approve any bid irregularities, and the item would have to come back to the Board for approval at their October meeting. Mr. Stahl asked why the item was just coming to the Board. Mr. Rovang said staff has been evaluating the watermain breaks. Mr. Reichert moved to approve entering into a contract agreement with the contractor submitting the low quotation, seconded by Mr. Stahl.

PROCLAMATION RECOGNIZING PUBLIC POWER WEEK, OCTOBER 2-8, 2011: ROCHESTER PUBLIC UTILITIES HELPS OUR COMMUNITY IN POWERFUL WAYS
