ITEM DESCRIPTION:

Three quotations were received and opened on September 20th, 2011, for the replacement of two pumping units. These new pumping units will replace the existing pumping units in Municipal Wells #13 and #17.

These two pumping units were identified in the 2011 Capital Budget for replacement, based on age and cumulative run-time hours.

Bergerson Caswell, Inc. had the lowest overall quotation on this project with a total price of \$55,075.00. A breakdown of the quotation is attached.

The Water Maintenance and Construction Capital Budget for 2011, includes \$60,000 for this project.
