ITEM DESCRIPTION:

Areas of the Service Center walkways have deteriorated to the extent that there is a potential risk to customers and employees. Funding for sidewalk replacement work was included in the 2010 budget to correct this safety issue.

RPU staff determined that this project also presented a perfect opportunity to leverage excess heating capacity of the Service Center geothermal system with an integrated under sidewalk snow-melt system. This system will save labor and equipment costs for snow removal and help eliminate risks to pedestrians.

Proposals with written quotes were requested from three contractors for the replacement of concrete sidewalks on the north and south sides of the Service Center and the installation of piping for the undersidewalk snow melt system. The following tab sheet contains pricing from the written quotes. The low quote was received from Alvin E. Benike, Inc.
