Verification of Transmission Line Clearance Calculations

ITEM DESCRIPTION:

Late in 2010, the North American Electric Reliability Corporation (NERC) issued Compliance Notices FAC-008 and FAC-009 which require all electric transmission owners to verify actual field conditions and line ratings methodology for their electric transmission system. In order to comply with this requirement, RPU is required to perform a survey of our existing transmission line corridor and have thermal line loading models developed to verify that our transmission facilities can be loaded to our listed ratings without resulting in NESC clearance violations.

Staff requested professional services proposals from several firms to perform this work and has selected Electrical Consultants, Inc. to perform a LIDAR survey of our transmission corridors, develop a PLS CAD model of our system and perform clearance analysis.

The estimated value of the professional services is \$127,512.50.

FOR CAPITAL PURCHASES/BIDS/MAJOR PROJECTS:

This NERC requirement came up after RPU's 2011 budget was submitted and is a non-budgeted item. Staff is recommending that the cost of this project be sourced from two other budgeted items.

- 1. Transfer of \$100,000 from the Transmission Line Q11 project (\$100,000 was budgeted). These funds were budgeted to purchase right-of-way for a future transmission line from Willow Creek Substation to the south in support of the Xcel Energy's RIGO initiative and a potential future RPU substation south of 48th Street SE.
- 2. Use of \$27,512.50 from cost center 116 budget for Professional Services (\$62,000 was budgeted)

UTILITY BOARD ACTION REQUESTED:

Management recommends that the Public Utility Board request the Common Council to approve a professional services contract with Electrical Consultants, Inc. subject to review and approval by the City Attorney's office, and that the Mayor and City Clerk execute the contract. The amount of contract is \$127,512.50.
