ITEM DESCRIPTION:

Plans for vehicle replacement in 2007 include a new Aerial Bucket truck for Electric Maintenance & Construction crews. The 2007 capital improvement budget included funds for this unit which replaces an existing unit. Bids were received from one vendor to supply the aerial device, body and installation on an RPU provided cab & chassis. Based on our evaluation of the bids which included price, delivery, previous experience with manufacturer and bidder, availability of service and repair facilities, compliance with specifications and operating & maintenance costs. DUECO was determined to be the lowest responsive bid with a price of \$80,257.00 which includes the trade in of Unit V116. A request to purchase a cab and chassis for this unit will be brought before the Board at a future meeting. The cab & chassis purchase will be off the State contract at an estimated cost of approximately \$63,000. The total price of the unit is within budget estimates.

Bid packages were sent to four vendors who have submitted bids in the past. Two no-bid letters, one bid, and one no-response were received. One of the vendors who submitted a no-bid letter indicated they have historically not been price competitive with this type of unit and chose not to invest the time in preparing a bid. The single bid received was within the expected price range.
